THE KIDSAFE RESPONSIBLE RETAILER AWARD 2013

Recognises retailers who actively promote childhood injury/accident prevention and the safety of children through action, increasing awareness or advocacy.

Criteria:

- Australian owned or operated retailers are eligible for nomination
- Nominations must include a brief description of retailer, for example:
 - * Type of business
 - * Length of time in industry
 - * Commitment to consumers
- A description of their activity that has promoted child injury/accident prevention and childhood safety. The description must provide responses to the questions:
 - * What has been done?
 - * How was it done?
 - * What effect or impact did it have?
- Evidence of action to promote child safety and accident prevention should also be provided (ie. photos, posters, etc).
